That the petitioner most humbly submits as under:-

1. That the petitioner of this Contempt Petition is the president of Kashmiri Pandits Samiti constituted by Pandit community who have not migrated and thus alongwith three other petitioners filed a writ petition which was registered under OWP No. 1986/2013 seeking extension of Jobs Package to the 561 educated and eligible youths of the Kashmiri Pandit Community who chose to live in Kashmir Valley after the mass exodus of the Community due to the political and armed uprising in the Valley *at par* granted under PM's Package for Relief and
